NEXT YEAR THE AMBULANCE BOARD MAY NEED TO LEVY THE FULL MIL. CURRENTLY ROGERS CITY, ANTRIM COUNTY, ST. IGNACE AND MACKINAW COUNTIES ARE REMAINING IN THIS SERVICE.

FIRE BOARD NEWS :THE FIRE BOARD WILL BE INSTALLING AN INDOOR WATER HYDRANT TO FILL TRUCKS.

NEW BUSINESS.

DRAIN ISSUES ON METZ HWY @ LEER ROAD. DUE TO NEW PIPING THAT IS INSTALLED IN THE SURROUNDING FIELDS, THE EXISTING DRAINS CANNOT HANDLE THE VOLUME OF WATER. THIS IS ACCORDING TO THE OFFICE OF DRAIN COMMISSIONER.
