#### **Pole Barn Building**

Michael Vogler has written up the following ad that will be published in the Presque Isle Newspapers. The minimum that the Village of Posen will accept is \$19,500.

The Village of Posen has for sale a lot with a pole barn. The lot is located in the Village of Posen on Second Avenue next to the Village Hall.

The lot is 65 feet by 128.25 feet and is legally described as Lot 4 and the South 15.06 feet of Lot 3, block 6, Plat of the Village of Vincent, as recorded as Liber a of Plats, Page 9, Presque Isle County Records.

The pole barn is 30 feet by 40 feet with a cement floor. It is wired except for the electrical box. There is no water connection to the property.

The property will be conveyed with the following deed restrictions:

- A. The property shall be used only for indoor storage.
- B. Outside storage is not allowed on the property.
- C. The property shall not be used for business or commercial purposes.

These restrictions will run with the land and enforceable by the Village of Posen.

The property has been surveyed.

The sale price is \$22,500.00
